All dogs must be available at Test Headquarters at 7:30 a.m. for Track Drawing for TD, and at 10:30 a.m. for Track Drawing for TDX. Judging will begin as soon after drawing as the first track is ready. A dog which is absent from the site at the scheduled time of drawing is marked "Absent" by the Judges. AKC Tracking Regulations, Ch. 2, Sec. 9.

NOTICE

As per Ch. 1, Sec 13 and 15 of the Tracking Regulations, if the limit for entries is not reached in one test and the limit for entries is exceeded in the other test, the number of tracks will be exchanged, up to the day of plotting at the rate of two TD tracks for one TDX track. This exchange for this these tests will not exceed a maximum of five [5] total TDX tracks, or a maximum of nine [9] total TD tracks.

ENTRY FEES

- Entry Fee: TD - \$75.00; TDX - \$100.00 (includes AKC Recording & Event Fees). Entries of dogs that have already earned their TD title will be accepted only in the event that the limit is not filled by dogs which have not yet passed an AKC Tracking Dog Test. A dog without a TD must include a valid original letter of certification with its entry as per Ch 3. Sec 2 of the Tracking Regulations.
- A Recording Fee of \$0.50 will be required for each dog entered at any Licensed or Member show, obedience trial, or tracking test. This recording fee is to be collected by the trial giving club and paid to the American Kennel Club, AKC Rule Ch 11, Sec. 2. An Event Fee of \$1.50 will be required for each dog entered.

- Use the official AKC entry form and write "Tracking Dog Test" or "Tracking Dog Excellent" in the Obedience Class space.
- Entries close at noon, Thursday, November 5, 2020, at the office of the Test Secretary. After this time no entries can be accepted, cancelled, altered or changed.
- Mail entries with fees, in US Funds and payable to Portland Dog Obedience Club, to James S. Corbett, Test Secretary, 23525 NW Howell Drive, Banks, OR 97106.
- Returned checks do not constitute a valid entry. The Secretary will add a collection fee to the amount of each returned check. Third party checks will not be accepted.
All entries must be submitted on Official AKC Entry Forms, one dog per entry form. Photocopies of front and back will be accepted only if legible, and official AKC size.
- Entries will not be accepted without signature, fees and back on entry form with agreement.

ADDITIONAL NOTICES

- Bitches in season may participate. The owner of such bitch in season must notify the Test Secretary prior to the drawing for tracks. Such bitch(es) will run only after all other dogs have run and must be kept away from the immediate vicinity of the test prior to running.
 - Entries for this TD and, TDX Test will be accepted until the official closing date, even though the advertised limit has been reached. Entries will be randomly drawn by the Test Secretary, except preference will be given to those dogs that have not earned either a TD title (if entered in the TD Test) or a TDX title (if entered in the TDX test). Acknowledgement will be mailed to all entrants as soon as practical. When the limit for each test has been drawn, all remaining entries, subject to the preferences set forth, shall be randomly drawn and assigned to an alternate list. In the event any accepted entries cancel, or are absent the day of the test, the Test Secretary will contact the alternates in the order they were drawn. The alternates will have the option of accepting or refusing to exhibit in the test. Entry fees will be refunded by mail to those alternates who do not participate.
 - Only one entry per dog will be accepted, as per Tracking Regulations, Ch 1, Sec 11.
 - If for any reason a dog making the draw cannot run, the fees will be refunded, provided an alternate can compete in their place.
 - Entry fee will not be refunded in the event of errors, nor in the event that a dog is absent, disqualified, excused by a veterinarian or judge or barred from competition by the test committee. If, because of riots, civil disturbances, or other acts beyond the control of management, it is impossible to open or complete this event, no refund of entries will be made.

Portland Dog Obedience Club will follow all the state and local requirements related to events held during the Covid-19 pandemic. We are also incorporating the AKC recommendations for tracking into our event. Because of the current coronavirus pandemic, many traditional aspects of our Champoeg Park events are changed. Please remember that the Covid 19 regulations or guidelines set by the State of Oregon Health Department are very fluid, and what may be in place today, may be changed by the time of our tracking events. WE MUST ABIDE BY THE POLICIES AND PROCEDURES IN PLACE AT THE TIME OF OUR EVENTS, NOT WHAT THEY ARE TODAY.

Masks are required for closer contact 6 feet or less, Social distancing is required for all activities.

For anyone who is not feeling well the day of the event, we please ask that you not to come or participate. We ask that a notification be given to the event secretary if a participant is unable to attend.

Participants will not be allowed in the meeting hall at the group loop. That will be specific for club use and there is a limit of no more than 10 people in there at a time. We will do all draws and communications with participants outside. We ask that participants wait near their vehicles until the time of the draw.

We will not provide any food or beverages for the event, and we ask that all individuals involved and participating bring their own food and beverages.

Participants must provide all their own transportation to and from the tracks. It is recommended they bring someone with them to the event to do their transporting. We request that participants park their vehicles with increased spacing around them. We will follow the parks rules on parking the day of the event and every vehicle must have a valid parking pass.

The club will have masks, gloves and hand sanitizer available at the event for those who need it.
